### 3. ELIGIBILITY:

To be eligible to enter or win, you must be a legal resident of the United States and at least 18 years or older or the age of majority in your resident state, whichever is older; at the time of entry (“**Entrant**”). The Promotion is void in Rhode Island, New York, Florida, U.S. Territories, outside of the United States, and where prohibited by law. Winner will be notified via email or other direct message (“**Win Notification**”) and will have **forty eight (48) hours** from the date of the Win Notification to acknowledge receipt of Win Notification and fulfill requirements described herein and therein to receive a Prize. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Promotion-related materials, privacy policy, or terms of use on Sponsor's website and/or the terms and conditions of the Official Rules, the Official Rules shall prevail, govern, and control, and the discrepancy will be resolved in Sponsor's sole and absolute discretion.
